4. First-aid Measures

Description of first-aid measures.

General advice.

Move victim to a safe isolated area. When symptoms persist or in all cases of doubt seek medical advice. Call a poison control center or doctor for treatment advice.

5. Fire-fighting Measures

Extinguishing media.

Suitable extinguishing media.

Use:. Dry powder. Alcohol-resistant foam. Carbon dioxide (CO₂). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

6. Accidental Release Measures

Personal precautions, protective equipment and emergency procedures.

Personal precautions.

Avoid contact with skin, eyes and clothing. Ensure adequate ventilation, especially in confined areas. All equipment used when handling the product must be grounded. Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Wear protective gloves/clothing and eye/face protection.
