# 4. First-aid Measures

### Description of first-aid measures.

### General advice.

Move victim to a safe isolated area. When symptoms persist or in all cases of doubt seek medical advice.

# 5. Fire-fighting Measures

### Extinguishing media.

### Suitable extinguishing media.

Use:. Dry powder. Alcohol-resistant foam. Carbon dioxide ( $CO_2$ ). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

### Extinguishing media which shall not be used for safety reasons.

Water may be unsuitable for extinguishing fires.

### Special hazards arising from the substance or mixture.

Vapors may travel to areas away from work site before igniting/flashing back to vapor source. Thermal decomposition can lead to release of irritating and toxic gases and vapors. ### Personal precautions.
